Commissioner Yorke also attended the NSAPG and shared discussions about growing or increasing this organization.

Commissioner Brooke attended a zoom meeting CAPG Executive Directors and Board Liaisons, and shared similar issues as Kentville's board. Some other community boards meet for 5-8 hours.
