#### PRESENTATIONS

# (a) Chester Avenue "Build Canada Fund" Award 2016/2017

Director Fred Whynot reported that a tender had been prepared for the renewal of water, sewer, and road systems of Chester Avenue, complete with 2/3 funding from the Province of Nova Scotia and Federal Government under the New Build Canada Program up to a total amount of \$2,964,655. Tenders closed on March 3<sup>rd</sup>, 2016 at 2 pm at the Town of Kentville. Tenders were reviewed by DesignPoint & Surveying Ltd. and they have confirmed that Howard Little Excavating Limited remains the lowest bidder and that their tender was compliant.

A meeting was held with representatives of the Town of Kentville, Design Point Engineering and Surveying Limited and Howard Little Excavating Limited to discuss both scope reduction and project phasing. The tender included the possibility of phasing the project should it not be covered under the original estimate. Phase 1 includes work from Main Street to MacDonald Avenue and has a tender price of \$1,391,739.75 + HST. Of this, water system renewal accounts for \$107,528.82 + HST and sanitary sewer renewal accounts for \$137,100.89 + HST. Engineering services would be around \$45,000 + HST, spread over the three cost centres. Phase 1 consists of an upgrade to the intersection of Chester Avenue and Main Street, complete replacement of the Eastern retaining walls, as well as sidewalk, storm, sanitary, and watermain renewals. This will probably the most difficult phase of work and a better estimate of remaining project costs, what could be deleted, etc. would be better known once the completion of this phase draws to a close. Phasing of the project will not increase the tender price. Phasing this project will also assist with the capital planning of other departments, utilities, etc.

Therefore, it was moved by Councilor Bill Boyd and Seconded by Councilor Bernie Cooper

that the tender for the Chester Avenue Upgrade be awarded to Howard Little Excavating Limited for the estimated price of \$2,836,279.21 + HST and that this project have the option to be phased over a two (2) year period

### (a) Council Advisory Committee 1. Debenture Funding Spring 2016

Councilor Bernie Cooper reported that at the March 14<sup>th</sup> meeting of Council Advisory Committee Meeting, Director Crowell provided a report regarding debenture insurance. NS Municipal Finance Corporation requires that, in order to streamline the debenture issue process, Council must approve a pre-approval resolution and forward it to the NS Municipal Finance Corporation.

#### 2. Withdrawal-Town Capital Reserve

Councilor Bernie Cooper reported that at the March 14<sup>th</sup> meeting of Council Advisory Committee Meeting, Director Crowell noted most Capital projects are complete and require a resolution of Council to make a withdrawal from reserves to fund the projects. The Town of Kentville Capital Reserve contains \$553,100 and after the withdrawal, it will contain \$428,077.

#### 3. Sundry Account Write Off

### 4. Tax Exemption – Section 69-2016/17

Councilor Bernie Cooper reported that at the March 14<sup>th</sup> meeting of Council Advisory Committee Meeting, Director Crowell noted that the Town of Kentville provides a partial tax exemption to individual property owners who must meet certain requirements.

As a guideline, the Town of Kentville sets the income ceiling at a level close to the maximum Old Age Security (OAS) and Guaranteed Income Supplement (GIS) paid to a married couple.

that Council approve the resolution for Low Income Tax Exemption for the year 2016/2017

# 5. Kings Regional Sewer Technical Committee Appointment

### 6. Proposed Property Assessed Clean Energy Program (PACE)

NEW BUSINESS	(a) <b>CPI – Salary Increases</b> CAO Phillips noted that the Town of Kentville Personnel and Policy Manual states that the cost of living increase shall be granted at the first of each fiscal year.
RECOMMENDATION TO COUNCIL	The CPI factor is based on the average CPI for the Province of Nova Scotia for the period of March the prior year to February the current year as posted by Statistics Canada. Data for February 2016 was released by Statistics Canada on March 18 <sup>th</sup> , 2016. For the period of March 2015 to February 2016, the average cost of living is 0.08%.
