4. PRESENTATION

5. CHIEFS REPORT

Chief Smith presented his report for November to December with highlights including training new officers, internal vs. external training, operating budget information, backcheck revenue, and fines. The year end report is being complied which will provide statistics for call volumes and each type of call, including domestic violence. Chief Smith does not expect a major variance in any of the categories. KPS has started tracking calls relating to the unhoused community, and approximately 25% of calls are for this category. Organizations that support the unhoused community are at full capacity. Statistics show that shoplifting has increased from last year with correlation with the unhoused community.

(e) Public Engagement

Chief Smith gave an update about the Coffee with a Cop event which was well received and very well attended. KPS will plan another one in the spring. The Christmas food and toy drive raised a lot of money and awareness for local organizations. The brunch fundraiser raised almost \$5000 for the Make a Wish Foundation. Community engagement is a strong part of the strategic plan. Officers regularly visit coffee shops in town to be seen and connect with residents and business owners.
