(a) Operations Update

I. Financial Report

Income Statement for the third quarter of 2022/2023 ending December 31, 2022 has been prepared by Acting Director of Finance, Robin Paish. KWC is 75% of the way through the fiscal year. Operating revenue is at 84.5% with metered sales at 77.2% and Public Fire Protection billed out to the Town & Municipality of Kings at an amount of \$635,997.

Director of Finance Debra Crowell had a recommendation prepared dated November 29, 2022 for the Kentville Water Commission write off four non-collectable accounts in the amount of \$169.43.

Motor Replacement on West End Well Pump: In mid-December KWC had a motor fail on one of the well pumps at the West End Wellhouse. A replacement motor was available in province and replaced during Boxing Week in December 2022. Upgrade to existing well houses are ongoing adding safeguards to help protect our motors from premature failure due to power imbalances and overcurrent draws.
