3. NEW BUSINESS

a. Operating Budget

i. Operating Revenue

Director Bell reported a total operating revenue decreased \$19, 350 (1.0%) from last year to \$1,934,450. Residential metered water sales are expected to increase \$5,000 from last year's budget and Commercial/Industrial metered water sales are expected to increase \$10,000 from last year's budget as several aging meters have been replaced or calibrated allowing actual water consumption from large users. Public Fire Protection rates have decreased \$35,050 and based on the formula approved at the last URB rate hearing. This will cover installation of larger pipes to meet water flow required for firefighting and charge to the Municipal units. The Town of Kentville and County of Kings also anticipated a slight increase in sprinkler service sales.

Points of Discussion

- Finance Director Wanda Matthews explained why the Fire Protection rate went down. The calculation as defined by URB considers the rate of return on the rate base (revenue divided by asset base). The asset base increased and revenue decreased creating a reduced rate of return.
- URB application fee is included in the 2023/24 budget.

ii. Operating Expenditures

Total operating expenditures have increased, \$51,260 or 3.0% for 2023/24 from last year.

iii. Non /Operating Revenue

No change, non-operating revenue reflects work completed and billed to external Parties, typically utility customers as well as Bad debts collected.

Debt charges have reduced by \$48,800 as outstanding principal and related Interest charges have dropped significantly.
