exposure limit in the new Investment Policy of 50%. He suggested a change that would bring the town's equities to 40%. There are several bonds maturing this month that will allow some changes to the portfolio.

That the committee direct the Investment Advisor to buy two bonds at \$500,000 each (similar to bond rating for Telus and Trans Canada Pipeline) from the proceeds of maturing bonds, to extend the existing bond ladder to 2030 and 2031, to be approved on June 16 or 17 by the committee chair.
