4. PRESENTATION

- (a) Alcoholics Anonymous

 Mark Zwicker brought information to the Board about Alcoholics Anonymous.
- (b) Kentville Business Community, Julie Ogilvie
 Julie Ogilvie brought some issues in the community to the Board regarding people
 experiencing homelessness in the downtown. She reported that some communities
 feel safe when the town is "clean" and others feel safe when the town has more
 enforcement officials. Chief Smith outlined the long-term strategy for supporting



including tracking. More conversations are needed (and are planned), with all levels of government, to more fully discuss issues and find solutions that support unhoused people, businesses and residents.

(c) Next presentations, potentially from Restorative Justice, Seniors Outreach and Valley Pride.

Chief Smith presented his reports for May, with highlights including staff barbeque, meetings with Chrysalis House and victims services, review of impairment offences, review of selection and hiring for the Community Crisis Navigator position.
