3. NEW BUSINESS

a. Operating Budget

i. Operating Revenue

 2025/26 total operating revenue increased \$21,400 (1.1%) from last year to \$2,022,750.

ii. Operating Expenditures

2025/26 total operating expenditures are expected to increase \$83,152.00 or
 4.4% from last year.

iii. Non /Operating Revenue

 Non-operating revenue reflects work completed and billed to external parties, typically utility customers, as well as "Bad debts collected". This revenue is forecast to decrease \$2,500 (49.0%) to reflect actual results.

iv. Non/Operating Expenditures

O Debt charges are nil in 2025/2026, as past debentures have been retired.

v. Budget Analysis

O To offset most of the forecast deficit, it is recommended that no 'Capital from Revenue' be funded this fiscal year, and that no operating revenue be transferred to Operating or Capital Reserves. It is also recommended to fully utilize the KWC Operating Reserve (\$60,010), reducing the forecast deficit to \$3,240.

Operating Revenue: \$2,022,750 Operating Expenditures: \$1,988,100

A \$168,250.00 operating deficit is forecast once non-operating expenditures are assigned against the Net Operating Revenue. The current water rates are not sustainable; a Water Rate study is currently underway and is expected to be taken to the Nova Scotia Regulatory and Appeals Board for review within the fiscal year.

b. Water Capital Budget: Projects total \$2,040,000 for 2025/26

- i. <u>To meet service demands</u>; these items are budgeted annually at \$57,500.00 in 2024/25 and are increased to \$65,000.00 this fiscal year.
- ii. <u>Projects:</u> Street renewal /extensions, residential water meter conversion program, land acquisition, booster stations, Chester Water Treatment Plant and equipment.
- iii. <u>Funding</u>: for the capital program will come from the following sources, ICIP Grant, KWC Capital Reserve, Kentville Water Commissions Depreciation Reserve Fund and operating



revenue, debenture dollar amount taken out in 2026/27 to fund KWC's portion of the 2025/26 ICIP project.
